Eliminate archaic references to exofficio members, President of Fayetteville and President of Fayetteville School District

Financial Report: David Wheeler called for review of financial reports

FFL Director of Finance Burnham gave a synopsis of The Year to Date Financial Report. Burnham indicated that June 30 would be the end of the FFL fiscal year; the FFL has changed to a fiscal calendar that will match the school district calendar.

Burnham presented the results of his board requested research on the misrepresentation of data and facts, including tax cap, cash reserves and fund balance that has been disseminated in the FM community and beyond. Burnham addressed board questions throughout his report.

Curtin requested that Burnham verify the packet that was received from T. Parker. Wheeler and Considine indicated that any necessary updates and edits will be made prior to posting next week.

PETITION FOR AMENDMENT OF CHARTER

TO THE REGENTS OF THE UNIVERSITY OF THE STATE OF NEW YORK

We the undersigned, being the President and Secretary of the Fayetteville Free Library do hereby apply to the Regents of the University of the State of New York for an amendment to the charter of the Fayetteville Free Library, and do make, sign and acknowledge the following statements:

- 1. The name of the corporation is Fayetteville Free Library.
- A provisional charter was granted to this corporation by the New York State Board of Regents on October 28, 1909. This provisional charter was made absolute by Regents action on June 22, 1911, and amended on March 26, 1993.
- 3. RESOLUTION OF A REGULAR MEETING OF THE BOARD OF TRUSTEES OF FAYETTEVILLE FREE LIBRARY

We, the undersigned, being the President and Secretary of Fayetteville Free Library, a corporation organized and existing pursuant to an absolute charter granted by the Regents of the University of the State of New York, hereby certify that the following is a true and complete copy of a resolution duly adopted by the affirmative vote of not less than three-fourths of the whole number of trustees at a meeting held on the 14th day of June 2017, and that such resolution remains in full force and effect.
